

## 連邦政府・管轄州政府による発表（3月23日付）

### 【カナダ全般】

（23日）トルドー首相は定例記者会見を行ったところ、同要旨は以下のとおり。

- 不要不急な外出の自粛と対人距離の十分な確保を引き続き強く求めたい。
- カナダ政府は、3000万加ドルを支出して感染拡大防止を目的とした広報政策を実施する。
- 農業・食品製造者のための貸付として50億加ドルの予算を用意。
- カナダ五輪委の東京五輪が予定通り開催される場合の不参加表明について、悲しい決定であるが完全に正しい判断であり、全員がこの決定に従うべきである。
- 1億9200万加ドルをワクチン開発のためにケベック州のメディカゴ社や国立研究所などの関連企業・機関に対して財政援助することを決定。
- （緊急事態法の適用可能性について問われ、）現時点でその必要性はないと考えているが、今晚州首相との電話会談で緊急事態法以外の手段としてどのようなものがあるのかを協議し、その上で必要性を検討する。

### 【ケベック州】

（23日）13時、ルゴー州首相は定例記者会見を行ったところ、同要旨は以下のとおり。

- 市中感染を確認したため、我々は新たな段階に来ている。本日からより適切に現状を伝えるため、昨日までの「確定」・「推定」の分類ではなく、2つを合算した陽性者数を報告する。現在、陽性者は628名（昨日「推定」と報告していた人数も合算して前日比409名増加）。陽性者の急増は、かかる表記変更に基づくところがあるので要留意。入院者数は、前日から21名増加して45名（内20名が集中治療者。昨日から7名増加）。
- 市中感染を確認したところ、更なる対応が必要となる。すなわち、遅くとも明夜0時（明24日（火）23:59）までに必要不可欠な業種を除く全ての企業・商業を4月13日まで閉鎖することを命令（ordonner）（注：オンタリオ州も同様の措置を本23日発表）。必要不可欠な業種に関するリストは速やかに公開の上、都度更新していくことになるが（注：下記ケベック州政府ウェブサイト参照）、例えば食料品店、薬局、警察・消防、医療関係、銀行、運送を含む食料関係業種は例外となる。（記者の質問に対して、）建設・製造業も閉鎖対象となるが、医療品製造企業などは必要不可欠なものとなる。レストランでのテイクアウト、デリバリー及びドライブスルーは引き続き認められる。ケベック酒公社（SAQ）は引き続き営業。
- 70歳以上の高齢者が最も感染後のリスクが高い状況に鑑みて、高齢者施設に入居する高齢者は、監視（supervision）がある場合を除き、外出を禁止する。

**【ニューブランズウィック州】**

(23日)現地14時半、ヒッグス州首相が記者会見を実施したところ、同要旨は以下のとおり。

●**Dr. Jennifer Russell, Chief Medical Officer of Health**

- A) No new cases to report; still 17 cases.
- B) PEI case: one confirmed case took March 16 WestJet Flight 3456 from Toronto (8:35 a.m.) to Moncton (12:02 p.m.), all passengers on this flight are asked to self-isolate for 14 days
- C) No longer need to send tests for confirmation in Winnipeg; final confirmation can be done in NB (Dr. Georges-L.-Dumont University Hospital Centre in Moncton).

●**NB Premier Blaine Higgs**

- A) For any questions or concern, the main resource is the NB Gov. website on Coronavirus; if the information is not available, call 1-844-462-8387 or email [helpaide@gnb.ca](mailto:helpaide@gnb.ca)
- B) Business monitoring for public health recommendation compliance; 94 % compliance; only 43 out of 762 businesses checked by the Dept. of Public Safety were not compliant with the measures. Next steps include follow-up visit/verification, then eventually fines and/or closure.
- C) Repurposing schools or hotels could be done at some point if necessary. All options will be considered for security and isolation.
- D) Premier Higgs is in favour of the Fed. Gov. triggering the Emergencies Act: there needs to be consistency/standards across Canada, unifying our response as a nation.

## 【ノバスコシア州】

(23日)現地15時、マクニール州首相は記者会見を行ったところ、同要旨は以下のとおり。

- 新たに13例の感染を確認。
- 本日より非常事態宣言が発効し、州内に入る全ての者に対して14日間の自主隔離要請を州境で行っている。
- 必要不可欠な理由でない限り越境しない、5人以上の集団行動はしない、雇用主は勧告を守り従業員が安心して働ける環境を整備してほしい、良識ある行動を取ってほしい等を改めて呼びかけ。

## 【プリンスエドワードアイランド州】

(23日)現地13時半、州主任保健局長が記者会見を行ったところ、同要旨は以下のとおり。

- A) Testing is being extended to any travelers from outside the country and outside the province who are having symptoms within the past 14 days. Anyone who has symptoms and any kind of travel history, call [811](tel:811). Looking for any evidence of community transmission.
- B) Parents must be direct in telling teenagers they must follow social distancing guidelines. Do not meet for coffee, do not go to friends' or neighbor's homes, only 1 person goes out for essentials/groceries.
- C) If returning from out-of-province or international travel, symptoms or not, go directly home, do not stop for groceries, do not stop for gas, etc., and self-isolate 14 days.
- D) People self-isolating can have delivery of essentials/groceries dropped on their doorstep, and get fresh air on their own property. Those self-isolating in apartment buildings in need of fresh air should not go use shared appliances/spaces (ex. laundry room), and must maintain social distancing.
- E) Received calls from 76 retired Islanders able to come back and help, thank you, and contact us if you would like to help too.
- F) In-province test results still 1-2 weeks away. NML (Winnipeg) notified that there will be more incoming tests from PEI and ready for these. There will be further updates later today about possible means to enforce the measures in place (self-isolation and social distancing).
- G) First (initial) confirmed case is feeling well and has reached the end of her self-isolation period.
- H) Testing clinics operating 8 hrs/day, 7 days/wk, continuing to use these for mild illness, those with severe acute respiratory illness will be tested regardless of travel history.
- I) PEI not at the stage to keep track of every person coming into through provincial entry

points, so limiting only to symptomatic persons. Later this afternoon, they will discuss powers available vs results and impacts if measures are not followed, to make further decisions.

- J) There was a discussion of Îles-de-la-Madeline persons going through PEI to get home from QC or other provinces (via Bridge for access to Ferry). It was said that they, like everyone, need to follow the guidelines, and that a scenario where they are asked to go straight through and not stop on PEI is being considered, but this is a complex situation that will be discussed/developed in coming days.
- K) Healthcare workers returning from international travel cannot return to work and must self-isolate 14 days (from March 8 onwards). Healthcare workers returning from out-of-province can return to work but closely monitoring for symptoms, unless returning from an outbreak area. Greater flexibility in latter cases since in Maritimes, not seeing sustained community transmission and number of returning healthcare professionals is dwindling as the measures are in place longer.

**【ニューファンドランド・ラブラドル州】**

(23日)現地15時、ボール州首相が記者会見を行ったところ、同要旨は以下のとおり。

- A) At today's press conference the NL's chief medical officer announced there are 15 new cases on Monday afternoon. Among 15 new cases, one is in the Central Health region, 14 are in the Eastern Health region. Eight cases in the Eastern region are linked to a previous case, two are travel-related.
- B) There are now totally 24 confirmed or presumptive cases in the province.
- C) Only family allowed to attend in the funeral. The province is also prohibiting gatherings of more than 10.
- D) Further mandatory closures to spas, esthetic services, hair salons, body piercing and tattoo shops.
- E) All travellers self-isolate for 14 days when returning to the province from anywhere in Canada and internationally.
