1 規則正しい生活の遵守

精神面が落ち込む、身体に何らかの影響があり得るため、可能な限り、起床・食事・睡眠について、通常どおり、規則正しい生活を守る。また、引きこもって運動不足になりやすいため、自宅内で体操等、意識的に身体を動かすと良い。

2 友人・知人等とのコミュニケーション維持

精神面の不安を和らげるため、電話、テレビ電話等、様々なツールを活用し、いつも以上にハードルを下げて、意識的に誰かと連絡を取り合う。

3 新型コロナ関連情報を見聞きしない時間を確保

ネットニュースを追いかけ続けたい気持ちは分かるが、1日30分でも良いので、新型コロナに関する情報に触れない時間を作る。特に、就寝前にスマホ等でニュースを追うことは控えると良い。

【1 カナダ全般】

(1)(2日)11時15分、トルドー首相は定例記者会見を行ったところ、同要旨は以下のとおり。

- 今晚、各州首相と今後の見通しを含めた情報共有を目的に電話会議を実施予定。
- (今後の見通しを問われ、)国民がより多くの情報を求めていることは承知している。国民には、近日中に更なる情報提供ができるだろう。しかしながら、今後を予測する上で最も重要なことは、現在の国民一人一人の取組である。
- (ケベック州や大西洋州が州境でのスクリーニングを強化する動きがある中、連邦政府として緊急事態宣言を発出する要否について問われ、)連邦の緊急事態宣言は、強力な手段であり、現時点、その段階にはない。各州は自力で状況を管理することができている。
- (中国から発注したマスクなどの医療防護品が米国に流れているとの報道があることに対して、)カナダに届くべき医療品がカナダにしっかり到着し使用されるようにやるべきことを行う。米国も非常に厳しい状況であるが、カナダも同様であり、この点は米国ともしっかり連携していく。
- (トルドー首相自身の健康について問われ、)問題ない。お気遣いに感謝。

(2)(1日)連邦財務大臣は新型コロナウイルスに対する経済対策である「緊急賃金補助制度(Canada Emergency Wage Subsidy)」の概要を公表。

- 緊急賃金補助制度は、従業員の所得(上限58,700ドル)に対して補助率75%となる。すなわち、週あたり最大8

47ドルの給付となる。本制度は、2020年3月15日から6月6日までの12週間実施される。

- 3月、4月又は5月の総収入が2019年同月と比較して少なくとも30%減少する適格雇用者は、この補助制度の活用が可能となる。適格雇用者には、公共部門の事業体を除き、全ての規模・セクターの雇用者が含まれる。
- 同様に収入減となる非営利団体や登録慈善団体に関し、政府は、収入の定義の妥当性を確保するため引き続き協議していく。政府はまた、非営利団体や慈善団体、特に COVID-19 に第一線で対応する団体への追加支援も検討している。詳細は近々発表される。
- 全ての雇用者は、支払い賃金を100%に引き上げるために最大限の努力をすることが期待される。
- 適格雇用者は、カナダ歳入庁のオンラインポータルを通じて申請を行うことが可能となる。申請方法に係る詳細は追って公表する。なお、緊急賃金補助制度の対象とならない者であっても以前公表した補助制度(3月18日から6月20日の前までに支払われた報酬の10%の補助、最大で被用者当たり1,375ドルかつ雇用者当たり25,000ドル)の対象となり得る。

【2 ケベック州】

(1)(2日)13時、ルゴー州首相は定例記者会見を行ったところ、同要旨は以下のとおり。

● 大多数の州民が要請事項を遵守していることを誇らしく思う。他方、依然として遵守していない個人・企業が散見される。従って、州警察やモントリオール市警等の主要市警に対して、取締りの強化を要請した。違反者に対しては、1000~6000加ドルの罰金が科せられる可能性がある。遵守違反は、多くの人間の命を危険に晒すことになる。

● 現在、陽性者は5518名(前日比907名増)、死亡者は3名増え、36名。入院者は、345名(前日比38名増、その内96名が集中医療者(前日比14名増))。

● 昨日も伝えたとおり、医療防護品の備蓄は向こう1週間分を確保している。(必要機材が米国等に流れてしまっているのではないかととの質問に対して、)ケベック州は、フリーランド連邦副首相やカナダの在外公館とも密に連携して必要な措置を講じている。必要な医療品の確保に向けて引き続き尽力。

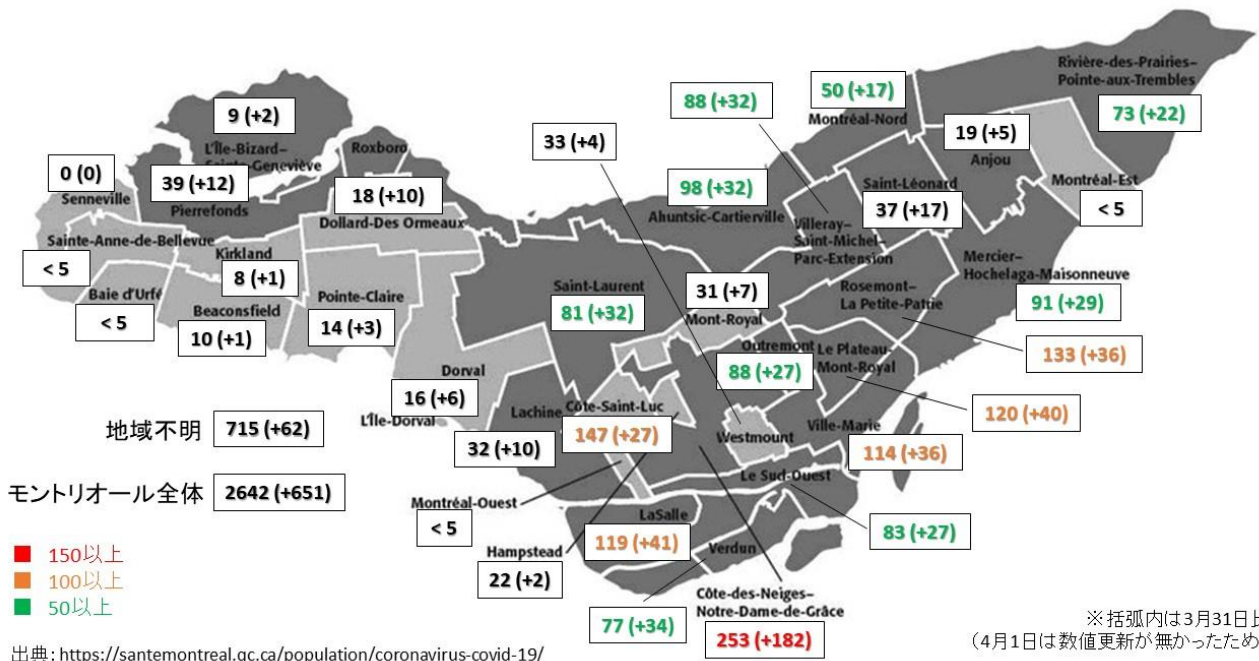

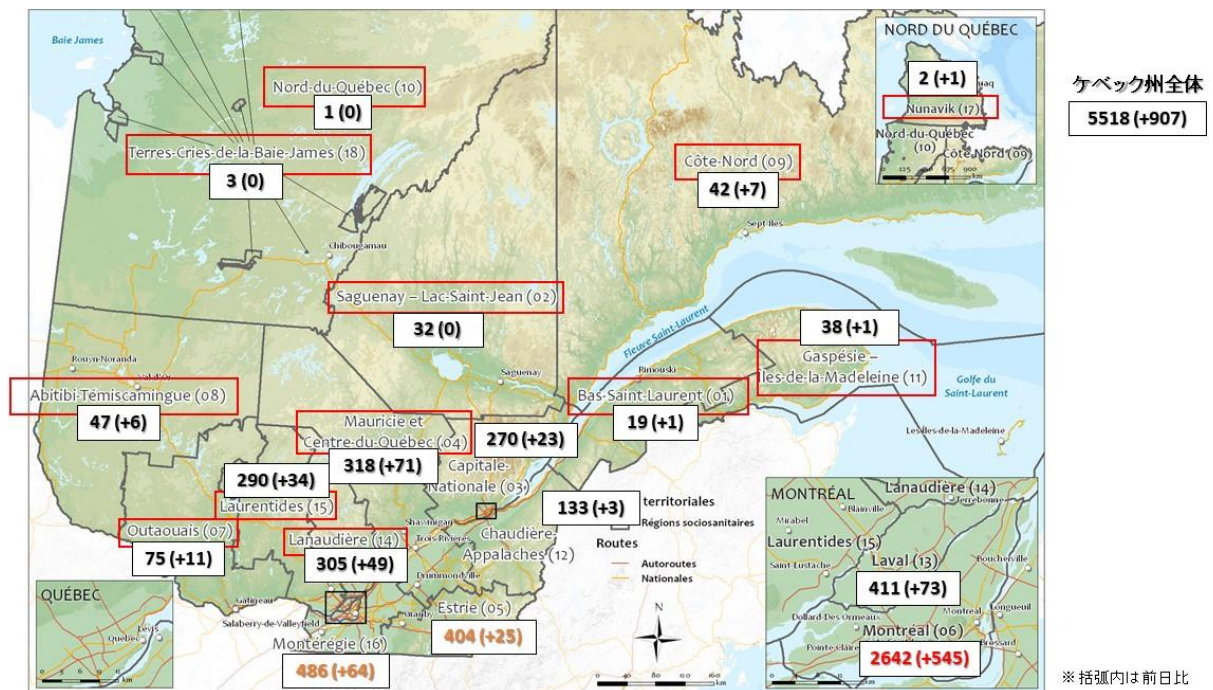

【3 ニューブランズウィック州】

(1) (2日) 現地14時半, ヒッグス州首相が記者会見を実施したところ, 同要旨は以下のとおり(州保健局長同席)。

- **Dr. Jennifer Russell, Chief Medical Officer of Health**

- Ten (10) new confirmed cases; total 91 confirmed cases in NB; Five individuals from one church community have tested positive; all the members of the church were contacted and informed of the situation and on measures to take.
- Pledges to tell the truth, share all pertinent information
- Warning against false information and the spreading of it on social media; use credible, official sources. Reject information from dubious sources.
- Information on public exposure will be available on the NB website for reference purposes
- If you are not a healthcare worker and you are not sick or have symptoms, wearing a mask is not recommended at this time.
- 450 calls a day to 811, half are related to COVID-19, around 45 fit the criteria for testing
- If you have questions about your symptoms, contact your family physician to book a virtual appointment or use the resources on the website eVisitNB.ca
- (Q&A) Both health networks are going to have a clinical trial for a COVID-19 treatment (hydroxychloroquine); they are still at the planning stage.

- **NB Premier Blaine Higgs**

- A) Thanks everyone's collaboration and contribution; reiterates different plans and measures put in place to support NB citizens and companies
- B) \$900 benefit program with Red Cross: to this day, over 50,000 people have registered
- C) Mandatory orders under the State of Emergency act have been revised; this includes among others:
 1. Camp grounds have been added to the list of businesses that are prohibited from admitting patrons
 2. Owners and managers of premises that permit seasonal docking of multiple recreational vessels must either prohibit the docking of vessels or take steps to ensure minimum interaction between people
 3. Owners and occupiers of land are now responsible to take all reasonable steps to prevent social or recreational gatherings; not all green spaces or beaches have to be closed, but any owner who decides to keep their space open are responsible for preventing gatherings.
 4. Individuals cannot go closer than 2 meters to another individual who is not a member of their household, except if it's for work: those who do not comply can now be charged for violating the orders.

(2) (2日) 現地11時, 州教育大臣 (Minister Dominic Cardy) が記者会見を行ったところ, 同要旨は以下のとおり。

- A) Schools in NB have been closed since March 16. Before the closures, measures had been taken to protect schools and early learning centers, such as asking anyone who had traveled internationally to avoid entering school, early-learning facilities and school district offices premises for 14 days after returning to NB in order to protect children and staff.
- B) From the beginning, the main concern has been public health and safety. And that is why, unless the situation improves drastically, schools in NB will remain closed for the remainder of the 2019-2020 school year, nor will the school calendar be extended. Home-learning options have been developed for students to continue their learning while schooling facilities are closed.
- C) Anglophone and francophone sectors have developed their own delivery plan and supporting material to reflect their unique approach and correspond to curriculum outcomes. In the days to come, schools in both sectors will be in contact with families to share home-learning options and activities to guide in the development of age-appropriate life skills as well as activities for physical and mental wellbeing.
- D) Students between kindergarten and grade 12 will be asked to dedicate between one hour to two hours and a half per day to complete these material depending on their grade levels. In addition to provided material, students are also encouraged to read for a minimum of thirty minutes per day, as well as engage in physical activity for a minimum of thirty minutes per day to promote physical health and mental wellbeing.
- E) Teachers will be participating in the planning and the development of home-learning options as well as preparing for an eventual return to school. They will also be contacting parents to encourage

wellness and a sense of connectedness within the school communities. Parents will have a key responsibility to encourage students to complete the material provided and continue their learning; the goal is not to recreate a classroom in their homes or to take on the full role of a teacher. Situations vary from family to family, parents should work together with instructors to develop solutions and adapt the material to their own home environment.

- F) All students who were positioned academically in January 2020 to continue on to the next grade level for the 2020-2021 school year will do so. The students who were positioned in January 2020 to graduate grade 12 in June 2020 and obtain their high school diplomas will do so. NB Government is working with post-secondary education institutions to make sure this situation does not prevent students from being eligible for admission to post-secondary education the following school year, should the situation have normalised by then.
- G) Decisions on graduation ceremonies and other related events will be made in the upcoming weeks based on direction from the office of the Chief Medical Officer of Health. All assessments, including exit surveys, will be suspended for the remainder of the year for both sectors.
- H) Examining the possibility of offering grade 12 students in the anglophone sector a French oral proficiency interviews online or by phone to those interested. Details forthcoming in the next few days.
- I) Mental health is a key concern, and resources have been made available in the last few weeks.
- J) Concerning the 2020-2021 school year start date: updates to come closer to September 2020 as it depends on the evolution of the COVID-19 situation.

【4 ノバスコシア州】

(1)(2日)現地15時、マクニール州首相は記者会見を行ったところ、同要旨は以下のとおり(州保健局長同席)。

●新たに20例の感染確認。市中感染が確定しているのは今のところ先日の1例のみ。現在のところ感染例の91%は国外旅行関連、9%はまだ調査中だが市中感染の可能性はある。

●今日から感染者数の推移、地域別、年齢別、性別データの公表を開始している(注:下記リンク参照)。

●マスクについてメディアでも話題になっているが、症状がないのにマスクをするのが良いのか否か、現在連邦保健省が方針見直しを行っている。エビデンスが常に変わっているのにそれに応じて州の方針も変えるようにする。

●財政支援プログラムを発表。1)自営で休業を余儀なくされている人、または解雇された人で失業手当受給資格のない人向けに1,000加ドルを支給する Worker Emergency Bridge Fund に2,000万加ドル支出、2)中小企業向けに過去の収益の15%または最大5,000加ドルを支給する Small Business Impact Grant にもう2,000万加ドル支出(詳細は以下州政府発表参照)。

●州内で感染の広がり、今後どうなるかについてのモデリングには現在取り組んでいるところである。大きな他州のように専門的リソースがそろっているわけではない小さな州にとっては難しい作業であるが、各州状況は異なるのでノバスコシア州独自のモデル作りは必要である。

●子供たちへ伝えたい。今の状況に混乱しているかもしれない。怖くなっているとしても当たり前である。孤独な気持ちになることがあるかもしれないが一人ではないことを知ってほしい。我々は全ての質問に答えられないかもしれないが、どんどん質問してほしい。

【5 プリンズエドワードアイランド州】

(1)(2日)現地16時、州大臣が記者会見を行ったところ、同要旨は以下のとおり(Ministers Myers(運輸・インフラ・エネルギー担当), Hudson(社会的発展・住宅担当), and MacKay(経済成長担当))。

● Myers

A) If you are experiencing urgent income loss due to COVID-19 but don't qualify for any existing federal or

provincial program: Islanders, NGOs, and businesses with COVID-19 losses and unable to access federal or provincial supports, may be eligible for new help under the 1M\$ COVID-19 Special Situation Fund. Call 1-833-533-9333, option 2 for social and community support. Information on all PEI programs, or, if not eligible, up to 1000\$ after April 16. Or option 3 for small business support, various programs, otherwise application for other funds; must apply by April 15. Either way, do not hesitate to contact us for any sort of help: funding, food, childcare, etc.

- B) We need to hear from those who have the most urgent needs first. We need to know if there is no help available. Do not “game the system”; rally together and hold each other up. Respect the process, apply through the proper program. Ensure that no Islander will be left behind.
- C) All non-essential government workers will continue to work from home until May 11. Enhancing enforcement of non-essential travel. As of screening start last night, asked 11 individuals in 4 separate vehicles, to turn around because deemed non-essential.

- **Hudson**

- A) Recognize essential work of persons working in seniors’ homes, community care, and residential programs across the province. They are stepping up, going above and beyond. Updates on programs: Of the 250,000\$ for United Way, 14 organizations have received approval for a total of 80,000\$ in funding.
- B) Tablets for seniors, 100 tablets purchased, being delivered to community care facilities across the province. A total of 15,000\$ has been raised on top of the 10,000\$ donated by province for this program.
- C) Regarding the 1-833 line, 469 calls received from Islanders in self-isolating Islanders for help, we have connected them with supports they need.
- D) Islanders Helping Islanders Directory: almost 1300 Islanders have visited this site: <http://princeedwardisland.ca/islandershelp> Thank you to MLAs for updating the directory, Thank you to the 182 organizations offering help across PEI.
- E) Supreme Court supported the province’s application to suspend enforcement of eviction orders unless an emergency situation exists.
- F) Ongoing dialogue with landlords, who will work with tenants to make arrangements.
- G) Rent supplement program announced earlier this week; more details: Temporary Rental Assistance Benefit, 1000\$ per household, assist with the cost of rent over the next three months. 500\$ for April, 250\$ for May, and for June. Paid directly to landlords. For more information, call 1-877-368-5770. Available online shortly. Students who live off-campus are also eligible for this program. Extra fund in April is a top-up ahead of federal support. We need to find ways to help each other. We will continue to adapt. No Islander left behind.

- **MacKay**

- A) Looking for something to do? Now is the time. I challenge all Islanders to learn something new. It’s important for our minds to continue growing, more skills than before. Holland College offering free online courses (business-related courses) visit <https://www.coursepark.com/eforcepei/>
- B) Businesses experiencing challenges, applaud many Island businesses innovating by shifting their

business to meet local needs.

- C) Announcing COVID-19 Business Adaptation Advice Program. Government will cover 100% of cost for businesses and entrepreneurs to hire a professional to provide advice or support on how to adapt or recover from impacts of COVID-19. Starting tomorrow (April 3), find more details at <https://www.princeedwardisland.ca/covidforbusiness>
- D) Also launching Community Champions Program. 300,000\$ partnership with Loblaws to meet food-related needs of PEI. Islanders who need help right now; seniors, families, etc. All 27 MLAs united to help Islanders with this program. Gift cards to be used at any Loblaw banner store. Not every program fits every Islander's need. Working hard to support Islanders.

(2) (2日) 現地13時半, 州保健当局が記者会見を行ったところ, 同要旨は以下のとおり(CPHO Dr. Heather Morrison, Health PEI Marion Dowling)。

- **CPHO Dr. Morrison**

- A) 1 new case, man in 50s in Queen's County, international travel, self-isolating, at home doing well. 3 cases are considered recovered, that is they completed their 14 days of self-isolation from symptoms' onset, and symptoms have resolved. Clarified that those self-isolating following travel outside the province, should stay separate from other household members, social distancing, enhanced cleaning of any shared spaces, using a separate bedroom and bathroom. If this is not possible, all members of the household must self-isolate together for 14 days. As of yesterday, 144 negative tests were received. The number of tests done at the Cough and Fever clinics have doubled. PEI has begun limited province-based testing (as opposed to sending to the NML in Winnipeg) as of yesterday afternoon.
- B) There are essential workers receiving help from others for childcare. Some are concerned that this may not comply with physical distancing guidelines. These particular circumstances are exceptions. Essential workers need to go to work, and their children need to be cared for during this time. Government is implementing emergency child care for essential workers in need of childcare to alleviate pressure on essential workers, in line with similar policies across the country. Children are screened daily, small number of children at one time, staggering lunchtimes and spaces.
- C) As regards the question about going for leisurely drives. It is allowed, but need to minimize the number of people in the vehicle if going, and keep frequency of such drives to a minimum, since driving more often means more trips to the gas station, increasing contact with others, which should be avoided.
- D) As regards correctional facilities, these are closed to volunteers and visitors, enhanced cleaning and disinfection protocols in place. New client admitted will be placed in a one-person-per-cell for 14 days, with extra cleaning, and clients will be permitted to be out of their cell one at a time.
- E) Essential workers coming to PEI for work need to self-isolate when they are not on the job. This is

emphasized at the Bridge, but this advice is especially for construction workers, truck drivers or healthcare workers, if not working, self-isolate. The majority are practicing excellent physical distancing, and self-isolating when returning from travel, Thank you. Some may not be following the directions we have given.

- F) Additional screening with extra highway safety officers at the Confederation Bridge. If travel deemed essential, then COVID-19 screening by public health officers: information about their health status, what they are doing, their contact information, and their anticipated self-isolation support is taken down.
- G) Going forward, we will be following up daily with every individual who is supposed to be self-isolating, to ensure they are complying with the order. If they are not, it will be referred to law enforcement to help us in making sure that people who need to be self-isolating, are doing so. PEI is densely populated across the province. Worrying about what will happen if we get widespread community transmission in PEI. I don't want us to become a situation similar to the cruise ships we see in the media. We need to continue to be diligent in our efforts to protect ourselves and our community. How long will it last? No definitive answer, but likely a couple of months. The more we comply with our public health measures, the better chance we have to flatten the curve and limit the spread of COVID-19 in our province.

● **Health PEI Dowling**

- A) Continuing efforts for preparation and support of the need for screening and testing. Staff and physicians at PCH and QEH are working to move patients to other locations for appropriate care. More than 75% target COVID-19 capacity has been achieved. Prepared for surge of patients we expect.
- B) Clarify our plan for hospitalized patients with COVID-19. Initial phase of response, patients will be cared for at QEH and PCH. Those needing ICU will be at QEH, if over-capacity, they will go to PCH. Both hospitals are ready and equipped for COVID-19 care. Continuing to preserve PPE now so we have it when we have hospitalization in the future.
- C) Cough and Fever clinics continue to see more patients in both Ch'town and S'side. Yesterday 83 patients were seen in Ch'town, and 57 in S'side. Access these clinics through referral from family doctor or nurse practitioner, or by calling 811. When arriving at these clinics, please remain in your vehicle until called for your appointment at the site. Health PEI continues to provide essential services only. Islanders should call their care provider to ensure their appointment is still going ahead before arriving. We thank you for your compliance, this helps us to continue to have no hospitalizations with this illness.
