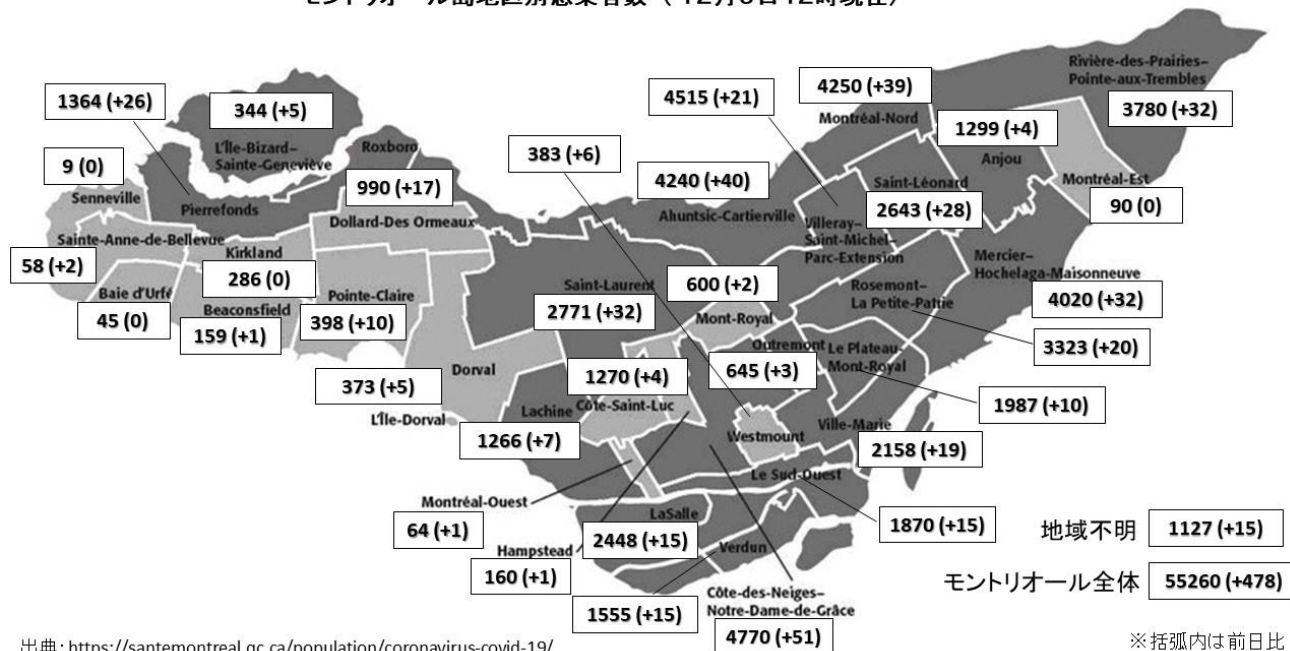

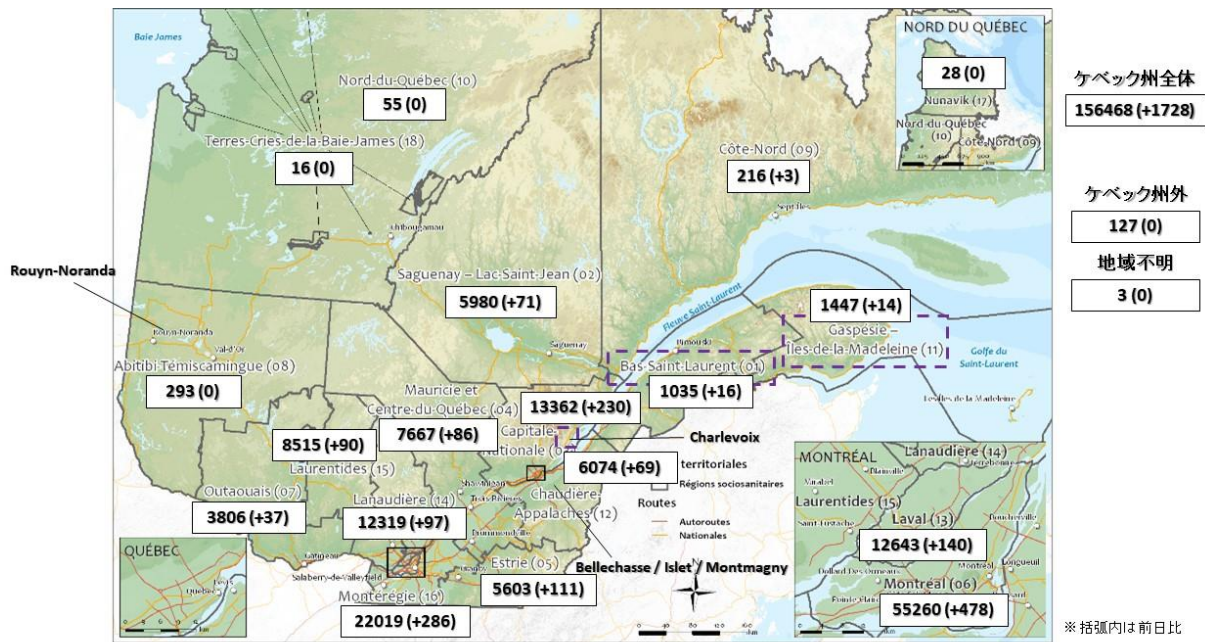

カナダ連邦

Santé Canada approuve le vaccin de Pfizer/BioNTech

Santé Canada apporte toutefois un bémol à cette homologation. Bien qu'elle affirme clairement dans ses documents d'approbation que les données fournies supportent favorablement l'efficacité et l'innocuité du vaccin Pfizer-BioNTech COVID-19, l'agence souligne que les données actuelles ne permettent pas de déterminer les effets secondaires à long terme du vaccin ni la durée de sa protection. Le Canada devrait recevoir 249 000 doses d'ici la fin de l'année.

ルソー州首相記者会見のポイント

- Il attend 55 000 doses d'ici le 4 janvier 2021. Ensuite, il doit recevoir 1,3 million de doses d'ici le 31 mars. Cela permettra d'inoculer plus de 655 mille personnes. Le PM espère que le 1/3 de ces personnes auront reçu le vaccin d'ici la fin janvier. Cela devrait permettre d'améliorer la situation de façon significative, surtout dans les hôpitaux. Le PM a réitéré l'ordre prioritaire pour la vaccination : CHSLD, personnel soignant et Résidence pour aînés.
- Le PM a demandé aux policiers de donner plus de contravention à ceux qui ne respectent pas les consignes sanitaires (une personne ou compagnie s'expose à une contravention allant jusqu'à 6000 \$).

Les premiers CHSLD qui recevront le vaccin contre la COVID-19 sont identifiés

Les résidents du Centre gériatrique Maimonides Donald Berman, à Côte-Saint-Luc, et du CHSLD Saint-Antoine, à Québec, seront les premiers au Québec à recevoir le vaccin mis au point par Pfizer et BioNTech.

COVID-19 Vaccine to Arrive Next Week (州政府発表)

December 8, 2020

Nova Scotia will receive its first allotment of 1950 doses of the Pfizer COVID-19 vaccine next week and will begin with immunizing health-care workers most directly involved in the COVID-19 response in Central Zone, as soon as the vaccine is approved by Health Canada.

Health-care workers to be immunized first include those working in COVID-19 care units, Regional Care Units and intensive care units that care for COVID-19 patients.

The focus for December is Central Zone, as the Pfizer vaccine cannot be moved around the province given its strict storage, handling and transportation requirements. The Pfizer vaccine must be stored at minus 70 Celsius.

Doses of the Moderna vaccine are also expected to begin arriving this month. They must be stored at minus 20 degrees Celsius, which is like many other vaccines.

The province is expected to receive a total of 150,000 doses in small, weekly allotments beginning the week of Dec. 15 and into the first three months of 2021. The vaccine is administered in two doses.

Like most other provinces, Nova Scotia is following the National Advisory Committee on Immunizations (NACI) guidance on COVID-19 vaccines. During the first three months of 2021, the focus will be to immunize:

- long-term care residents and staff
- seniors who live in the community beginning with those who are over 80 years of age, then people over 75 and then people over 70.
- health-care workers directly involved in patient care

Public Advisory: One New Case of COVID-19 in Newfoundland and Labrador

Effective 12:01 a.m. on Thursday, December 10, informal gatherings with family and friends are reduced to a maximum of 20 people. The amended Special Measures Order will be posted online later today.

At these gatherings, individuals are reminded that:

- The maximum number of people allowed is 20;
- Gatherings should only be with your close and consistent contacts;
- The number of people should only be as large as the space permits and physical distancing must be maintained;
- Providing and sharing food is not recommended;
- People should practice proper cough and sneeze etiquette;
- People should practice good hand hygiene;
- Bathrooms should be well-stocked with liquid soap, towels, and a hands-free waste basket; and,
- If you are sick and invited to a gathering, you must stay home.
